Background:

Mineral Inheritors Rights Association (MIRA), formally established in March 2020, is an emerging coalition of diverse civil society groups and networks in India working to ensure democracy, social justice, equity, transparency, and accountability in the extractive sector. It is affiliated to the global Publish What You Pay (PWYP) movement.

MIRA's Vision: Our collective vision is to create and ensure "A country with fair and effective governance over natural resources, including minerals, which are a shared inheritance with the State as trustee for the people and especially future generations."

MIRA resonates with the PWYP's vision, mission, its operating principles, and the strategic goals.

MIRA's membership standards:

Code of Conduct for members:

Responsibilities:

- To periodically review the coalition's work and future course of action.
- To devise policies on internal transparency, accountability, good governance and gender equity.
- To provide strategic guidance to meet the coalition's objectives.
- To define standard operating procedures for management of the coalition's finances, keep an oversight and report on inflow and utilization of funds.
- To extend fundraising support including identifying funding resources, developing proposals.
- To resolve any conflicts within the coalition.
- To participate and approve the National Coordinator's performance review and oversee any future recruitments.
- To sign-off media releases as and when required.
- To actively participate in SC meetings to be held every 2 months.
- To avoid conflicts of interest in matters of decision making.
