Coalition Updates.

- MIRA and Environics Trust along with its member organisations, had recently conducted a pilot study of 574 projects of the District Mineral Foundation Trust in 4 states- Rajasthan, Odisha, Chhattisgarh and Jharkhand. Our survey report, **"GROUND-TRUTHING THE IMPLEMENTATION OF THE DISTRICT MINERAL FOUNDATION TRUST (DMFT)"** was released on 17th October, during the MIRA Coalition meeting. - On 12th October, Rahul Basu, Advisory Member, MIRA & Research Director, Goa Foundation, shared his insights on 'Minerals as a Shared Inheritance' at the General Assembly of the Congress of

Nations and States (CNS), an international, independent, and permanent forum.

- Mazdoor Kisan Shakti Sangathan (MKSS) along with several civil society groups, organised State-wide Jawabdehi Andolan (Accountability movement) in the month of September, demanding for a Social Accountability Law in Rajasthan. Their consistent efforts has resulted in the announcement of 'THE RAJASTHAN GUARANTEED DELIVERY OF PUBLIC SERVICES AND ACCOUNTABILITY BILL, 2022' by the Government of Rajasthan.
